AUGUST 2020

SEPTEMBER 2020

On September 1, 2020, the Join It Membership Database was successfully integrated into the UMES NAA website and made available to alumni to pay national dues. All active members were manually assigned Membership ID numbers and the digital membership cards were designed. Membership form updated and new process for paying dues went into effect.

On September 9, 2020, an automated email was sent out to all inactive alumni encouraging them to reactivate their memberships with their payment of dues.

On September 10, 2020, an automated email was sent out to all active members encouraging them to become familiar with the membership database by logging in to ensure the accuracy of their personal information.

On September 11, 2020, a telephone call was placed to all alumni that had a telephone number in the membership database but no email address on file. There were 79 alumni missing email addresses. Out of that 79, 27 are missing telephone numbers in addition to email addresses. The remaining 52 alumni were called, and I was able to reach 26 of them.

On September 17, 2020, I was invited to the Baltimore Alumni Chapter's "Cocktails & Conversations" Virtual Meet & Greet to discuss the alumni benefits and process changes.

On September 24, 2020, the first Membership Committee Meeting was held at 7pm EST.

On September 25, 2020, a membership brochure was emailed to all local chapter presidents, the NAA executive board, board of directors and to the alumni body via email and social media platforms. It was placed on the website as well.

The UMES NAA app is still being finalized and is coming together smoothly. The app is expected to go to the Apple and Google Play developers soon.

OCTOBER 2020

On October 8, 2020 the Membership Committee's sub-committee met to finalize details regarding the membership drive event scheduled for November 13, 2020. We were joined by Anshay Tull, 3rd Vice President of the UMES NAA.

On October 8, 2020, I reached out to Kadeem Turnbull, UMES Director of Alumni Relations & Special Events to request a conference to discuss speaking to our future alumni prior to the upcoming Winter 2020 graduation.

On October 13, 2020, I attended the local chapter meeting of the Greater Annapolis Alumni Chapter via videoconference to discuss dues payments, member benefits, membership database and changes in processes.

NOVEMBER 2020

The UMES NAA app was submitted to the Apple and Google Play developers on Monday, November 2, 2020.

On November 12, 2021 a final sub-committee meeting was held to finalize the Hawk Family Tailgate & Telethon.

On November 14, 2020 the Hawk Family Tailgate & Telethon sold 137 tickets and brought in over 100 memberships. Non-hawk vendor fees totaled \$450.00. The event brought in \$2,800.00 in profit.

On November 17, 2020, I attended the local chapter meeting of the Southeastern Virginia Alumni Chapter via videoconference.

On November 19, 2020, I was present at UMES' commencement to connect with the Winter 2020 graduates and speak with them about the importance of joining the UMES NAA. I was able to sign many of them up for free annual membership.

DECEMBER 2020

On December 7, 2020 a membership committee meeting was held to discuss the pros and cons of the Hawk Family Tailgate.

On December 28, 2020 a membership committee meeting was held to discuss Quarter 2 goals.

JANUARY 2021

On January 11, 2021 a membership committee meeting was held to further explore Quarter 2 goals.

The app was kicked back twice due to privacy policy and payments feature. Updates were made and the app was resubmitted to Apple on January 18, 2021.

On January 18, 2021 a membership committee meeting was held to finalize Quarter 2 goals.

FEBRUARY 2021

Hawk Month was a success and although it did not increase membership, it did make a profit of ten dollars (\$10.00) and Hawks had fun during Black History Month trivia, UMES trivia, BINGO and Hawk Family Feud. Most of the participants were already dues-paying members.

MARCH 2021

On March 4, 2021 a membership committee meeting was held to discuss Quarter 3 goals.

APRIL 2021

On April 6, 2021, I was able to join the Tri-County Alumni Chapter for their monthly meeting to discuss membership. It was success and a lot of feedback was provided.

On April 15, 2021, I participated in a seminar with the UMES Office of Residence Life entitled, "Life After Graduation" where I was able to engage students preparing to graduate about alumni participating, resume writing, credit building and employment search. Frederick Grant from the MD Eastern Shore Tri-County Alumni Chapter was able to Co-Host and offer valuable information as well.

MAY 2021

A Chat & Chew was held on Saturday, May 1, 2021 at 10am at the University of Maryland Eastern Shore. The meeting was held with executive board members of all active local alumni chapters to prepare for the next membership year and to answer questions regarding dues, membership types, activities, processes, etc. It was successful and every chapter was represented.

On May 4, 2021, the Southern Maryland Alumni Chapter's articles of incorporation were approved. Although they will remain under the umbrella of the National Alumni Association, they now benefit from their own non-profit and tax exempt status. A letter of approval was received from Dr. Anderson and was forwarded to the University of Maryland Systems Board of Regents for approval.

The Supervision & Leadership Affinity Alumni Chapter has fulfilled its requirements for members according to the Bylaws and is working to have their executive board plus, one regular member to pay their national dues so that they may reactivate

effective July 1, 2021. So far, three (3) of their members have paid dues.

Some graduates from 2017-2021 are attending membership meetings, joining committees and reaching out to network.

More alumni are seeing the benefit of joining the UMES NAA and retention efforts are looking good for the 2021-2022 membership year when compared to the start of the 2020-2021 membership year.

During this era the chapter received its Maryland State tax exempt status and worked closely with the National Alumni Association in establishing its (501C3) incorporation status. Under the leadership of Delphine Lee the Baltimore Chapter developed a website and recruited young alumni to help move the chapter to its next level.

On March 19, 2010 the University of Maryland Eastern Shore Baltimore Alumni chapter had a changing of the guards after 17yrs. The new executive board consists of older and younger alumni. The Executive Board positions of 3rd Vice President, 4th Vice President and Financial Secretary are currently vacant.

Chapter meetings are held on the 4th Saturday of each month at 10am from September through June of each year. The Chapter currently meets at the Waldorf Center for Higher Education located at 3261 Old Washington Road Waldorf, Maryland 20602. Due to the COVID-19 pandemic videoconferencing is being utilized until meetings can be held again in person. For 2020, chapter meetings were held during the months of February, March, April, May, June, September and December. Executive Board Meetings were held in June, September and December.

II. Chapter Financials

The SoMD Alumni Chapter's finances are funded through a combination of annual membership dues (\$30.00) and fundraisers. As of December 31, 2020, the chapter had an account balance of \$3,749.57.

III. 2020 Goals

The SoMD Alumni Chapter currently have three signature events; two of which are in partnership with the DC HBCU Alumni Alliance. Those programs, held annually, are the DC HBCU Alumni Alliance 5K/2K Run/Walk, the HBCU Alumni Alliance Black-Tie Gala and the Linganore Wine Festival Party Bus. The 5K/2K Walk/Run was scheduled to be held on Saturday, July 11, 2020 at Freedom Plaza in Washington, DC. Due to the pandemic, the race has been postponed until July 10, 2021 at Freedom Plaza in Washington, DC. The Black-Tie Gala scheduled for September 2020 has now been postponed until Saturday, September 25, 2021 at the National Museum of Women in the Arts located at 1250 New York Avenue, NW Washington, DC.

These two signature events are major fundraisers for the chapter. The uniqueness of the events is that it allows the chapter to partner with all of the other HBCUs that are a part of the HBCU Alumni Alliance. When members register for the events and select “UMES Southern Maryland Alumni Chapter”, during registration, the chapter receives a portion of the registration fee. The Linganore Wine Festival Party Bus was scheduled to take place on Saturday, May 23, 2020 but was postponed until October 10, 2020 and then postponed again until May 22, 2021 due to the pandemic. Currently, SoMD Alumni Chapter allocates twenty-five percent (25%) of the proceeds from each fundraiser to donate to UMES. Due to the pandemic, the SoMD Alumni Chapter was not able to fundraise in person so a virtual t-shirt fundraiser was held in July 2020, with UMES approval. 105 t-shirts were sold and \$1,151.51 was raised.

In the Fall of 2020, the SoMD Alumni Chapter made a \$1,000.00 donation to UMES' Circle of Hope fund and presented the check during the Homecoming Basketball Game. In July 2020, UMES Junior, Akiya Smith (Electrical Engineering Major) was awarded a \$1,000.00 scholarship from the DC HBCU Alumni Alliance. There were only two recipients of this year's DC HBCU Alumni Alliance scholarship. In July 2020, SoMD Alumni Chapter was also able to assist the UMES Office of Admissions & Recruitment by writing personalized postcards to incoming freshman residing in the Southern Maryland area welcoming them to UMES for the Fall 2020 academic year. On Monday, October 26, 2020, the SoMD Alumni Chapter kicked off a social media voting campaign geared to increase community's knowledge of voting deadlines and poll locations. Our Recording Secretary, Valerie Harris also volunteered as a poll worker.

IV. Challenges

Like many others, SoMD Alumni Chapter has been impacted by the COVID-19 pandemic as we have not been able to host programs and events in the manner in which we are accustomed to and out of an abundance of caution as well adherence to local and state guidelines. However, we were able to adjust so that we could achieve one fundraiser and one social action event.

V. Goals 2021

The SoMD Alumni Chapter plans to work diligently on signature fundraising events (Linganore Wine Festival Party Bus in May 2021, DC HBCU Alumni Alliance 5K/2K Run/Walk in July 2021 & DC HBCU Alumni Alliance Black-Tie Gala in September 2021), establish a scholarship program and work to recruit new members to include the 2020 Winter graduates. We also plan to reengage past members and work on a retention plan to ensure that members remain active and financial.

VI. Assistance from the NAA

At this time, the SoMD Alumni Chapter requests assistance with advertising events and having the Executive Board attend at least one of our signature fundraising events, preferably the Black-Tie Gala.

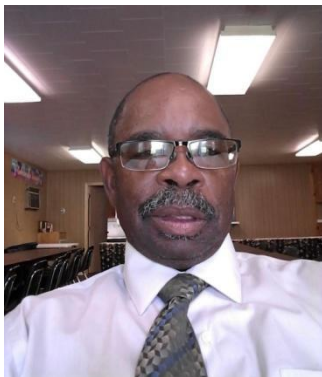

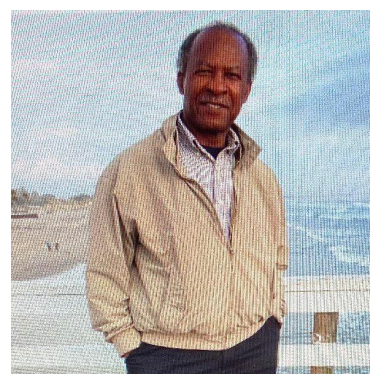

EXECUTIVE SUMMARY

As of September 30, 2021 the WMAA chapter has 41 financial members. Participation in the chapters’ monthly meetings varies with an average participation of 10 chapter members attending.

II. Chapter Financials

WMAA Chapter finances are funded through a combination of membership dues and fundraisers. In May 2021, the WMAA chapter voted to increase local membership dues to \$35 annually. The WMAA Chapter collects membership dues in the amount \$65 for each chapter year, \$30 of which are forwarded to the NAA for members' National dues. The WMAA waives local chapter membership dues (one year only) for current year UMES graduates.

III. Accomplishments of Program Activities

The WMAA's primary goals for this chapter year were to continue to increase the Chapter's membership, raise monies to continue to contribute to the chapter's UMES endowment fund, award a scholarship to an enrolled freshman for the fall 2021 school year and help UMES in their recruitment efforts for new students.

- The WMAA Chapter held a "Ten Dollar-A-Thon" event in April 2021 in which members participated in a ZOOM telethon call and solicited friends and alumni for at least a \$10 donation to the WMAA for the scholarship fund. The WMAA collected more than \$3,000 during and after the event.
- The WMAA held its 7th annual Endowment Breakfast event on September 18, 2021 at the Harborside Hotel in Oxon Hill Maryland. The WMAA hosted more than 140 guests including Prince George's County Executive Angela Alsobrooks, Maryland State's Attorney Aisha Braveboy and Maryland State Senators Joanne Benson and Obie Patterson. This year's keynote speaker was our own UMES President, Dr. Heidi Anderson. A longtime WMAA Chapter member and past NAA and WMAA Chapter President, McKinley Hayes was this year's Endowment Breakfast honoree.
- During this chapter year WMAA participated in the Prince George's County Adopt-A-Road program. The Chapter members, friends and family volunteered their time to remove trash from an approximate one mile stretch of Addison Road between Sheriff Road and Eastern Avenue in Prince George's County. The Chapter cleaned the road twice this chapter year.
- The WMAA Chapter awarded a \$1,000 scholarship to Jaidyn McCullough. Jaidyn graduated from Prince George's County public schools and is attending UMES for the fall 2021 semester.
- The WMAA 2nd VP hosts a membership drive bowling event once a month.

IV. Challenges for the Chapter

The WMAA Chapter attracted a few more recent UMES grads this year than in years past. The Chapter continued to deal with COVID-19 restrictions and have not been able to meet in-person since March 2020. The Chapter had some limited successes this year with fundraising efforts but still looks to find a signature fundraiser to sustain the Chapter's philanthropic efforts.

V. Upcoming Chapter year goals

- The goals for the upcoming Chapter year are similar to those of previous years. A primary goal of the Chapter continues to be to establish a major fundraiser to increase operating capital, charitable contributions and the Chapter's Endowment fund.
- The Chapter plans to award at least one \$1,000 scholarship to an incoming freshman student for the fall 2022 semester.
- The Chapter plans to participate in the cleaning of the WMAA adopted road in Prince Georges County, MD once a quarter of the following year.
- The Chapter plans to work more to integrate and better utilize technology to better reach younger Alumni and expand communications capabilities.
- The Chapter hopes the COVID-19 pandemic dissipates enough for the membership to be able to participate in more in-person membership and fundraising activities.
