Call To Order & Welcome

The Annual meeting of University of Maryland Eastern Shore National Alumni Association was called to order by Madam President, Teonna Wallop at 5:00pm. Madam President opened the meeting by welcoming President Anderson, NAA Board Members and UMES Alumni.

The Alma Mater and Alumni Prayer was done.

Standing Rules were read to all by Dr. Thomas Holt (Parliamentarian).

The purpose of this meeting was to provide Alumni the current state of the University (briefed by President Anderson) and to give current status of the NAA financials and updates of all committees.

The **State of the University** was briefed by the UMES President, Dr. Heidi Anderson. Dr. Anderson addressed many areas including, branding, enrollment, academic programs, facilities & capital projects, and national recognition. This information gave Alumni the current state of the university as well as the path forward to continue enhancing our programs, encouraging learning, promoting awareness and essentially continue being successful in educating our youth.

- Enrollment decreased since 2016; need to determine problem and how to move forward. Fall 2023 increased 13% and 5 ½% (last year) and 1½% (previous year). Need to look at business model on how to do things differently.
- Over last eight years the university is becoming more of a STEAM (Science, Tech, Engineering, Agriculture, Aviation Sciences, Mathematics) university.
- Pipelines are critical so we need to connect with children in high schools early. Working with Wallops Island; partnering with a Charter school in Ohio on how to get students into science-related HBCUs. Twenty of their students (rising 10th graders) came last summer and exposed them to STEAM. Talking about bringing them back the next two years so they can enroll in future.
- UMES is the only HBCU to receive the Medical Institute Award which aims at creating scientists of color. This allowed university to bring in 10 STEAM stars. Recruited 1st cohort this summer.
 - Aviation is doing partnerships with several companies including Republic and Alaska airlines.
 - Two grants on research side came in to help expand what we are doing. 10M-bring students in to get them exposed to research; and partnership with Princeton univ for their fusion energy program.
 - Two new buildings: Agriculture and School of Pharmacy (phase 1) buildings.
- 577M- used monies for scholarships, rebranding, marketing, new 11 academic programs (BS, MS, PhD); conferences for students (e.g., PA Program students, were on NBC Today Show which is free advertising).
- Embarking on having a School of Veterinarian Medicine. This will be the only one in the state of Maryland; 2nd in the country. The College Park Veterinarian Program is in Virginia. University also made connections with the Veterinarian Board of Accreditations.
- UMES hosted "An Evening with Joyce Abbott" who is a UMES Alum. (The TV Show Abbott Elementary is based on Ms. Abbott).
 - Athletics has a new Athletic Director. New Baseball Coach. About to upgrade the Tawes gym; need to have a Wellness Center. Have a number of students involved in e-sports which will be added in Tawes. Looking at upgrading baseball/softball fields with turf.

Purpose: The aim of this event was to increase chapter visibility in the Greater Atlanta area.

Outcome: Chapter members wore paraphernalia with Hawks around the country in participation of this event.

Pros: By wearing paraphernalia throughout the state, UMES visibility increased.

Cons: Unfortunately, none of our chapter members remembered to take pictures and post on the @HBCU Walking Billboard site on our assigned day.

Impact: Increased visibility can aid to increased membership; so, this event was a step towards this goal.

Mar 15- June 15, 2023: Wear Your Paraphernalia Wednesday

Purpose: The aim of this event was to increase chapter visibility in the Greater Atlanta area.

Outcome: Several chapter members were approached by local alumni not in our chapter. As a result, our chapter increased in visibility.

Pros: Wearing paraphernalia on the same day, throughout the state, allowed us to have a broader reach as most of our events take place in the city of Atlanta.

Cons: Unfortunately, chapter members forgot to take pictures and post on their social media sites.

Impact: Ultimately, this event increased UMES and GAAC visibility in the Greater Atlanta Area.

April 21, 2023: Janet Jackson/Ludacris Concert Ticket Raffle

Purpose: The aim of this event was to increase chapter visibility as well as generate funds.

Outcome: The chapter sold 6 tickets and there was a \$150 profit to the chapter.

Pros: Some funds were generated for the chapter and visibility was raised.

Cons: We offered tickets to the Maryland show instead of Atlanta and participation was very limited.

Impact: Two Hawks were able to attend the concert along with Board of Directors members. As a result, chapter visibility was able to increase and the winners learned more about NAA chapters.

June 24, 2023: Atlanta HBCU Alliance 5K

Purpose: The aim of this event was to increase chapter visibility in the Greater Atlanta area as well as generate funds.

Outcome: The chapter obtained the 15 required registrants necessary to receive payout. Also, we produced the four required volunteers. Additionally, we had two out of town Hawks participate as a part of our team. Moreover, someone made a \$900 donation to our chapter.

Pros: Visibility increased exponentially as a result of participating in this event. Also, we were able to generate funds for scholarships.

Cons: It was difficult to obtain the 15 required registrants as we do not have 15 members in our chapter. In fact, smaller chapters are not provided any adjustments, and again, provided many challenges in gathering the necessary number of attendees.

Impact: Through participation in this event, we were able to award \$1000 in scholarships to Georgia Hawks.

June 26, 2023: INROADS College Fair at Kennesaw State University

Purpose: The aim of this event was to recruit potential Georgia students to attend UMES.

Outcome: Over 100 students visited our table and received promotional materials.

Pros: Students that had never heard of UMES were provided information about scholarships, admissions, and programs.

Impact: Attending this event spread awareness of both our chapter and UMES.

September 22, 2022:	Dine to Donate Boston's Restaurant Waldorf, MD
Purpose:	A fundraiser to raise money for the operating budget.
Outcome:	We were able to raise fifty dollars (\$50.00) and reclaim one (1) member.
Pros:	There was no overhead costs associated with the event.
Cons:	We had very little participants and needed to advertise the event more.
Impact:	Supporting our budget increases the reach of our chapter's efforts.
October 14, 2022:	Meet & Greet Blue Dyer Distillery Waldorf, MD
Purpose:	To increase membership at the local and national level as well as recruit volunteers for our membership committee.
Outcome:	We had twenty (20) participants at the event and the majority were not financial members.
Pros:	We were able to connect with Hawks that were not otherwise connected to a chapter. We also had the support of UMES Baltimore Alumni Chapter, Inc.
Cons:	We were only able to get three (3) hawks to pay dues at the event.
Impact:	While we were only able to gain three (3) dues-paying members, we had members to commit to attend local alumni chapter meetings.
October 29, 2022:	Halloween Fright Night Blue Moon Washington, DC
Purpose:	To raise money to support a donation to the Fallen Hawks Fund, UMES Pep Band and Ways & Means budget.
Outcome:	We sold sixty-three (63) tickets and made a profit of \$955.00.
Pros:	It was a great turnout for a first-time event. The guests adhered to the theme and we were able to provide cash prizes for the costume contest.
Cons:	We would need more venue space instead of a section.
Impact:	We were able to donate \$238.75 towards the UMES Pep Band getting us closer to our homecoming donation goal of \$5,000.00 which would exceed last year's donation of \$2,000.00.

November 11, 2022: Alumni Central University of Maryland Eastern Shore Princess Anne, MD

Purpose:	Joined the UMES National Alumni Association to sign alumni up for local
	and national membership during homecoming.

Outcome: We had members to join our chapter, but the numbers are not known at this time.

Pros: It was a great way to connect/reconnect with alumni.

Cons: For Homecoming 2023, we will do a better job with tracking the numbers.

Impact: Our chapter advertises sixty dollars (\$60.00) dues to ensure that local dues and national dues are both paid at the same time. This aligns with the membership goals of both the chapter and the association.

December 16, 2022: Adopt-A-Hawk UMES Princess Anne, MD 21853

- Purpose: To provide support to homeless college students and students that cannot afford to return home for the holidays. In 2019, nearly 167,000 students from 171 two-year institutions and 56 four-year institutions responded to the Real College Survey reporting that 39% respondents were food insecure in the thirty (30) days prior; 46% of respondents were housing insecure in the previous year; and 17% of respondents were homeless in the previous year.
- Outcome: We were able to provide eight (8) gift baskets to four male students and four female students. We were also able to provide lunch to forty (40) students.
- Pros: It was a great way to bring awareness to food and housing insecurities.
- Cons: We would like to be able to provide gift baskets to more than eight (8) students.
- Impact:Supporting our student hawks always aligns with the mission and values
of both the chapter and the association. We doubled the amount of gift
baskets delivered in comparison to the 2021-2022 membership year.

February 16, 2023: Hawks Take Flight Tulum, Mexico

Purpose: To continue to host a fundraiser during the timeframe of when our past homecomings were and to celebrate our chapter's charter anniversary.

Outcome: We raised one thousand three hundred dollars (\$1,300.00) and had thirteen (13) participants.

Pros:	The event is always a relaxing and innovative strategy to raise money.
Cons:	We were not able to carry out the service portion of the trip but will ensure that the service component is incorporated into the 2024 trip.
Impact:	We saw an increase of \$800.00 in fundraising efforts compared to the 2021-2022 membership year. We were also able to host a membership lunch while in Tulum which resulted in three members joining our chapter, one member joining the NAA, one member being connected to the Philadelphia Alumni Chapter and one member being connected to the NYC Tri-State Alumni Chapter.
April 29, 2023:	Fitness Marathon St. Charles High School Waldorf, MD 20602
Purpose:	Communities of color are at increased risk for experiencing serious illness if they become infected with coronavirus due to higher rates of certain underlying health conditions compared to Whites. Our goal was to provide a free fitness event that would encourage the community to increase their physical activity which is encouraged to remove themselves from high risk categories.
Outcome:	We had approximately forty (40) people in attendance.
Pros:	We received a three thousand dollars (\$3,000.00) sponsorship from CareFirst BlueCross BlueShield which covered all expenses. The participants, chapter, and instructors enjoyed the variety that came with having four (4) varying group exercise events.
Cons:	Consideration will be given to a different location for the event given the venue's lack of effective communication about reserving the space.
Impact:	Supporting the community always aligns with the mission and values of both the chapter and the association. For this event, we charged \$5.00 for the event and had five (5) more people to attend than when the event was offered for free in 2022.
May 27, 2023:	Linganore Caribbean Wine Festival Bus Trip Mount Airy, MD
Purpose:	To provide a safe means for our members to travel to the wine festival and back since it is one (1) hour and thirty (30) minutes, one way, from the Southern Maryland area.
Outcome:	We were able to fill the 56-passenger bus and raise one hundred fifty-five dollars (\$155.00).
Pros:	It's a popular event that a lot of alumni attend.
Cons:	The increase in transportation to the event decreased the profit by \$62.50.
Impact:	Event keeps alumni engaged and we are always able to connect with

	alumni that are not connected to a local alumni chapter. Our tent and table are always visible during the event to bring noticeability to the university.
June 24, 2023:	<u>10th Annual DC HBCU Alumni Alliance 5K/2K The St. James Complex</u> Springfield, VA
Purpose:	To raise money to support our scholarship fund scheduled to launch in January 2024.
Outcome:	We had twenty-two people to register for the event. The proceeds are still being calculated.
Pros:	The race is a great partnership with the DC HBCU Alumni Alliance and a great way to encourage people to become more active. We had an increase of 14 registrations compared to 2022.
Cons:	The chapter needs to revisit the marketing strategy for the event although we have a substantial increase in registrations compared to 2022.
Impact:	Supporting our student hawks via scholarships has been a goal of the chapter and we have raised enough money to launch our chapter scholarship.

Other Accomplishments:

November 12, 2022 – Donated \$5,100.00 back to UMES to support the pep band.

February 16, 2023 - We were awarded a CareFirst BlueCross BlueShield sponsorship in the amount of \$3,000.00 for the second year in a row.

June 30, 2023 – Our chapter has a total of fifteen (15) certified alumni recruiters.

Financials:

For the purposes of the NAA's annual meeting, our chapter is exempt from providing financials as we are not under the NAA group exemption as a separately incorporated chapter. Our chapter's financials are not incorporated into the NAA's financial reporting obligations.
